#### **ILLINOIS RESIDENTS**

- 16 hours of Concealed Carry firearms training provided by an ISP approved Instructor.
- Electronic Copy of my training certificate(s). You will be required to upload your electronic certificate during the application process.
- An Illinois Digital I.D.

- A Valid Driver's License or State Identification card.

- A head and shoulder electronic photograph taken within the last 30 days.
- Be able to provide the last ten years of residency.
- Fingerprints Electronic fingerprints will expedite your application! Specify to the Live Scan vendor that your fingerprint application is for the Concealed Carry application (ORI = IL920707Z, Purpose Code = CCW).

NOTE: Applicants will be assigned a transaction control number (TCN) at the time of fingerprinting and will be required to retain that TCN to complete the application.


# Public Key Infrastructure (PKI)

- The comprehensive system required to provide public-key encryption and digital signature services is known as a public-key infrastructure (PKI). The purpose of a public-key infrastructure is to manage keys and certificates, which are used for identification, entitlements, verification, and privacy.
- The State of Illinois has it's own PKI environment that is managed by Central Management Services

# State of Illinois Digital ID


- After completing the registration process the citizen will be issued a unique digital ID (similar to a user id and password)
- This digital ID will enable a citizen to identify or authenticate themselves to the Conceal Carry Application process and to actually sign the application digitally. Referred to as a digital signature.






Subscribers should enter personal information <u>exactly</u> as it appears on their valid Illinois Drivers License or ID Card.

#### Common Errors include:


- Subscriber has entered a period after middle initial.
- 2. Subscriber has not entered 3 digits in weight field (i.e. 098).
- 3. For subscribers with a last name starting with "O" as in O'Neil, please make sure you enter a letter "O" rather than an numeric zero as the first letter your driver's license number. All State of Illinois Drivers license numbers start with the first letter of your last name, all State of Illinois Identification Numbers end with the first letter of your last name.
