HOW DOES INSTALLING THE LAW-BOLT REMOVE THE FIREARM FROM REGISTRATION REQUIREMENTS IN ILLINOIS

According to the definitions in Illinois, Public Act 102-1116. The Law Weapons AR Bolt Conversion Kit offers a transformative solution for any AR15-style rifle or pistol, converting it into a manually operated straight-pull bolt action firearm. The act states, **"Assault weapon" does not include: A firearm that is manually operated by bolt, pump, lever or slide action unless the firearm is a shotgun with a revolving cylinder."**

Even if the firearm aligns with the criteria stipulated in 720 ILCS 5/24-1.9(a)(1)(A) or is explicitly listed as an assault weapon by 720 ILCS 5/24-1.9(a)(1)(J), this conversion makes sure such firearm no longer falls within the scope of classification as an assault weapon in compliance with Illinois law.

OUR LAW FIRM LEGAL OPINION

This memorandum responds to your request for legal review of whether producing and selling a bolt to be used in what Illinois classifies an "assault weapon" would comply with state law requirements.¹

Per our discussion, you described your desire to produce and sell a modified bolt that would stop a rifle's direct impingement gas system from operating. Instead, a firearms user would be required to manually operate the bolt to extract and eject the spent ammunition casing. The user then allows the bolt to go forward, loading the next cartridge into the firearm chamber locking the bolt in place before another round can be fired.

Your described process of producing and selling a bolt part should alter what Illinois otherwise qualifies as an "assault weapon" from the definition of an assault weapon by converting a semiautomatic firearm to a straight pull bolt action firearm. Because Illinois law specifically exempts from the definition of "assault weapon," any firearm "that is manually operated by bolt," this item, and the firearm it modifies, would seem to comply with the law.

This constitutes my professional assessment of 720 ILCS 5/24-1.9 and 720 ILCS 5/24-1. Under existing law, the production and sale of your device should qualify as an exception to firearms using it being deemed a prohibited "assault weapon."

NOTE: Care should be taken about keeping parts that might readily modify a weapon back into a prohibited assault weapon under the law. Thus, whichever parts the bolt replaces should likely be discarded to cure any concern of violating these additional restrictions.
